This policy document has been written to ensure understand of the expectations of Rep Teams as it pertains to uniform items. This policy document will be reviewed on a yearly basis and updated accordingly. Any updates required throughout the year to provide clarity will be added on an as needed basis.

Jerseys: (revised September 2021)

Effective the 2022 Season RMMSA will not be supplying the Rep Teams with uniforms.

Each team and/or player will be responsible to purchase at least two jerseys for the year. **The Uniform Deposit of \$100 will be discontinued going forward.**

Custom Jerseys:

Teams have the following options for purchase of their Jerseys:

- Teams may purchase full sets of jerseys, red, gray and/or white through Rep Uniform Manager and have them customized with the players last name and number.
- **Sponsorship on Jerseys: Approved on a trial basis. To be voted on prior to 2023 orders going to MVP. Restrictions: 1 Sponsor per set of Jerseys, size to remain 2" x 3" maximum on a sleeve, Sponsors Logo to be sent to the Rep Uniform Manager who will confirm with MVP that it meets the requirements. ****



Sponsorship / Advertising:

The position of RMMSA is that Sponsorship / Advertising can be placed on any item that does not have the players number it. Any uniform item that contains sponsorship **cannot** be worn on the field when playing a game. **** Exclusion above.** These items may be worn by the players during warmups but must be removed before the start of the game.

A mock-up of advertising must be submitted to the current Rep uniform Manager(s) for approval prior to proceeding with orders.

Main points:

- Items cannot contain sponsorship and the player's number
- Items cannot be worn on the field during games
- Mock-ups of the advertising and placement to be sent to Rep Uniform Manager and for approval before orders are placed.
